

### HOTSPOTS in the WESTERN BALKANS

- Local hotspots closely connected to regional criminal dynamics characterised by clientelism/patronage politics
- Little focus on local criminal dynamics and actors in often highly localised (but connected) ecosystem
- Many local criminal groups deeply entrenched with strong external links and political protection – 'crime governance'
- Crisis in regional civic governance "alternative visions" and "antibodies against criminality"
- Weakness of local civil society in a context where focus is on nationally focussed incentives for change





# GLOBAL HOTSPOTS OF WB ORGANIZED CRIME

The problem of organized crime in the Western Balkans has largely moved abroad. However:

- Criminals and groups come and go to/through the region.
  - Some are embedded at home.
  - Others operate in the global hotspots and use the WB to lie low, avoid exposure or find a safe haven.

Most successful groups seem to have taken advantage of networks in the 'Yugosphere', combined with opportunities afforded by global hotspots.



### **ANTI-CORRUPTION MAIN ISSUES**

- Persisting structural shortcomings.
- Organized corruption: links political/ business and criminal establishments
- Lack of independence of anti-corruption control structures
- Need for further professional and capacity development
- Lack of an independent media
- Not sufficient civil society organizations working in anticorruption arena.
- Insufficient research and academic silence
- Apathy of citizens and brain drain.
  - Lack of independent and professional oversight.

### CRIMINAL CONFIGURATION

- The Balkan route is still one of the most-trafficked from East to West and has expanded both in its geographical width as well as in terms of its content.
- The Balkan route was, for years, the transnational organized crime infrastructural investment and it still is. It is well-maintained and highly modernized to absorb the expanded intensity and diversity.
- Close linkages between organized crime and political and business environments.
- Violence, extortion, corruption and organized crime infiltration in political and economic establishments.
- But, the WB became too small for international organized crime operations: it serves a an
  export-import and still transit and hiding hub



### POLITICAL COVER

The broader ecosystem of crime is characterized by clientelism, patronage and in some cases state capture.

#### Power in the Western Balkans is based on political clientelism.

- Criminal groups provide money and muscle in election campaigns.
- Individuals or political parties provide protection for criminal activities.
- Loose investment rules and favoritism enable money laundering both of domestic and international origin and both within and outside the WB

#### Political clientelism also spreads to the world of business.

- The public sector is one of the biggest employers.
- Political elites use the public sector to enrich themselves.

#### Political cover and business clientelism meet:

- Loose investment rules and favoritism enable money laundering both of domestic and international origin and both within and outside the WB
- WB OC on the international plane is the main mediator and facilitator



### CRIMINAL CULTURAL STYLE

Limited economic opportunities

Weak rule of law

Political Cover and corrupt political establishment

Distrust in the state/government: thugs in power

Presence of organized crime in the formal economy: state capture

Illicit profit making: cultural tolerance

Illicit means: corruption/fraud/ tax evasion – cultural acceptance

# WHERE DO ORGANIZED CRIME AND CORRUPTION SIT IN THE WESTERN BALKANS?

- Historically organized crime and corruption belong to the 'underworld': even UNTOC/UNCAC portray its 'underworld' image.
- Today, and in particular in the Western Balkans, only some part of organized crime and corruption is strictly confined to the underworlds.
- Much of it is in the mezzo-world: on the thin edge between illicit and licit.
- Some of it walks straight on the promenade.
- It is not anymore only domestic and regional but rather international
- Anti-crime culture must go beyond the underworld and become a part of the dominant civil culture.

At the Conference the GI-TOC reports on Hotspots of Organized Crime in WB and Corruption and Anti-Corruption in WB as well as UNODC Measurement and Assessment of Organized Crime in WB and SII Illicit Trade in South Easter Europe/WB were presented and discussed



#### WILTON PARK CONFERENCE RECOMMENDATIONS

Enhance collaborative approaches to sharing information and data for policy use

**Enhance support for criminal justice systems** 

Strengthen civil society and media freedoms

Increase donor coordination and assess donor activity

- Closing the EU membership.
- Challenging the non-democratic and corrupt political and business establishments
- Increasing the responsibility of the political establishment for the respect of the internationally and domestically undertaken reform and anti-corruption commitments
- Criminal justice response to be continuously updated, adjusted and aligned.
- Promoting professionalism, independence and resilience among criminal justice personnel
- Attention to the presence of organized crime with both old and emerging forms and methods; exported and imported

- Increasing knowledge, information sharing and advancing informed policy making and evaluation.
- Establishing a regional platform for strategic directions against organized crime and corruption.
- Engaging civil society against the criminal culture, in debate and as an oversight.
- Increasing community resilience against organized crime, corruption and abuse of power
- Investing in hotspots economic, cultural and political development to practically address the factors making them vulnerable to organized crime
- Building trust at the regional level.
